Govt Approved Air India Disinvestment; Tata Sons Won the Bid for Acquiring Air India fro Rs 18,000 crore



T ata Sons Private Ltd subsidiary Talace Pvt Ltd has won the final bid for acquiring the national carrier Air India by submitting Rs 18,000 crore bid. The Cabinet Committee on Economic Affairs (CCEA) - empowered Air India Specific Alternative Mechanism (AISAM) approved the highest price bid of Talace Pvt Ltd, a wholly-owned subsidiary of Tata Sons Pvt. Ltd.

- The bid involves sale of 100 percent stake Al (the shareholding of Government of India), 100 percent stake in Al's subsidiary Air India Express (AIXL) and 50 percent in the joint venture Air India SATS (Air India SATS Airport Services Private Limited).
- The total permanent and contractual employee strength of Air India & AIXL is 13,500.

- The winning bid of Rs 18,000 crore as Enterprise Value (EV) does not include noncore assets including land and building, valued at Rs 14,718 crore, which are to be transferred to Gol's Air India Asset Holding Limited (AIAHL).
- The AISAM comprises Union Minister for Home Affairs and Cooperation Amit Shah; Union Minister for Finance & Corporate Affairs Nirmala Sitharaman; Union Minister for Commerce and Industry Piyush Goyal and Union Civil Aviation Minister Jyotiraditya Scindia.

Govt to Sell the Subsidiaries of Air India

Following the privatisation of Air India (AI), the Government of India (GoI) started its asset disposal programme of AI's subsidiaries.

- Air India Asset Holdings Pvt Ltd (AIAHL), the wholly-owned regional subsidiary of AI consists of a company of ground handling, engineering, and Alliance Air to be privatised for clearing of its liabilities and disposal of assets.
- Recently, Talace Pvt Ltd (the subsidiary of Tata Sons Private Ltd) won the final bid for acquiring the national carrier AI by submitting Rs 18,000 crore bid.

- In 2019, Gol has formed a Special Purpose Vehicle (SPV) AIAHL for holding debt and non-core assets of the Air India group.


This NOC will be followed by a security background check after which the airline will apply for AoP (air operator permit) from the Directorate General of Civil Aviation (DGCA).

 PFC is the largest infrastructure finance company exclusively dedicated to the power sector under the administrative control of the power ministry.

Maharatna status :

With this, PFC can now invest up to 5000 crore, or 15 percent of its net worth, in a single project. It enhances powers to the PFC board while taking financial decisions.

- Navratna and Miniratna CPSEs can invest up to Rs 1,000 crore and Rs 500 crore, respectively.

Cabinet Approval on Oct 12, 2021

The Union Cabinet chaired by Prime Minister Narendra Modi has given its following approvals.

 The Union Cabinet has approved the continuation of Swachh Bharat Mission (Urban) till \$2025-26\$ with an outlay of Rs 1,41,600 crores w.e.f October 1,2021 .lt will be regarded as SBM-Urban \$2.0\$ with aim of 'Garbage Free' Urban India.

- The Union Cabinet also approved the Atal Mission for Rejuvenation and Urban Transformation \$2.0\$ (AMRUT 2.0) till \$2025-26\$ with an outlay of Rs 2,77,000 crore. It aims to make cities 'water secure' and 'self-sustainable' through circular economy of water.
- The Union Cabinet cleared the proposal of affiliation of 100 schools, including both private and public, with the Sainik School Society, under the Ministry of Defence (MoD).
- CCEA approved the proposal of the Department of Fertilizers for fixation of Nutrient Based Subsidy (NBS) Rates for P&K Fertilizers for the year 2021-22(from 1st October, 2021 to 31st March, 2022).

NHAI and TIDCO signs MoU for Development of Multi-Modal Logistics Park in Chennai Port's Land

A virtual Memorandum of Understanding (MoU) was signed with NHAI (National Highways Authority of India) and TIDCO (Tamil Nadu Industrial Development Corporation) for the development of Multimodal Logistics Park (MMLP) with an investment of Rs 1200 crore in Mappedu village in Tiruvallur district in Chennai Port's land.

The union minister for Ports, Shipping and Waterways, Sarbanand Sonowal has announced establishment of a Special Purpose Vehicle (SPV) for development of a MMLP at V.O. Chidambaranar Port (VOC) Port in Chennai. The MMLP will be developed through Public-Private Partnership (PPP). The SPV will provide land and connectivity and the MMLP infrastructure to be developed by a private developer. NHAI/ NHIDCL (National Highways and Infrastructure Development Corporation Limited) under Ministry of Road Transport and Highways have been assigned the task of developing MMLPs

Stakeholder :

- There will be three stakeholders- Chennai Port Authority, TIDCO and NHAI will be equity partners.
- The equity contribution/investment of the Chennai Port is the cost of the land amounting to INR 167 crore, NHAI contribution is INR 130 crore and that of State government through TIDCO is INR 50 crore.

Key points :

- The Government of India has taken a novel initiative to develop 35 Multimodal Logistic Parks (MMLP) under Bharatmala Pariyojana across the country. Whereas in this network of MMLPs, Chennai is among the first to be chosen for implementation.
- As a part of MMLP, the Chennai Port authority has acquired a land parcel of 121.74 acres on a 99-year lease basis from SIPCOT for the purpose of developing a Dry Port.
- The MMLP will provide smooth Rail-road connectivity, proximity to Main Sea Route, all weather operational conditions, and geographic position to link Eastern coast with the Western coast.

It will facilitate seamless multi modal freight transfer, and specialized storage solutions, such as cold storage, warehouses equipped with mechanized material handling and inter modal transfer terminals for containers, bulk and break-bulk cargo.

MoRTH announces 'Good Samaritans' scheme to award lifesavers

In October 2021, the Ministry of Road Transport and Highways (MoRTH) announced 'Good Samaritans' scheme to award & appreciate citizens who save the lives of road accident victims by admitting them to hospital with the 'Golden Hour'. The lifesavers will be provided with a cash reward of Rs 5000 per incident per individual along with an appreciation certificate.

- Golden Hour is the first 60 minutes from the point of accident or trauma, in which the victim's survival rate is at the highest.
- Scheme Validity The scheme will be effective from October 15,2021 till March 31, 2026.
- State & Union Territory Governments will be allocated with Rs 5 lakhs per month for awarding Good Samaritans, which will be altered on a monthly basis based on the need.

Only 25 CPSEs tagged as 'excellent' in the Performance Assessment by DPE

In accordance with the performance review conducted by the department of public enterprises (DPE) for 2019-2020, only 25 of the 144 Central Public Sector Enterprises (CPSEs) have been tagged as 'excellent'.

This figure is down by 10 from 35 as compared to 2018-2019 mainly due to depreciation of the rupee, stricter assessment and drop in net profits.

Among other categories, 28 units are categorized as poor, 18 as very good, 66 as good; and 30 as fair.

India signs MoU with Russia for Diammonium Phosphate Fertilizer Supply

I ndia signed a long-term Memorandum of Understanding (MoU) with Russia for DAP (Di-Ammonium Phosphate) fertilizer supply. The reason behind this agreement is to stabilize the prices of DAP and to reduce dependence on countries like Jordan, Morocco, and China.

Key Points :

- Earlier, the Ministry of Fertilizer headed by Union Minister Mansukh Mandaviya directed all companies not to increase the retail prices of DAP and other phosphatic fertilizers as these are required by farmers during the current Rabi season.
- Government also increased the subsidy on DAP by 140 % from Rs 500 per bag to Rs 1,200 per bag.
- Notably, the Central Government allocated around Rs 79,600 crore for fertilizer subsidy in the budget for 2021-22.
- After urea, Di-ammonium phosphate (DAP) fertilizer is the most widely used

Govt launches India's 1st 'One Health' Consortium for Surveillance of Bacterial, Viral Infections

O n October 14, 2021, the Department of Biotechnology (DBT) launched India's 1st 'One Health' consortium to carry out surveillance of important bacterial, viral and parasitic infections of zoonotic as well as transboundary pathogens. It will consist of 27 organizations led by DBT-National Institute of Animal Biotechnology (NIAB), Hyderabad (Telangana).

- It was launched by Dr Renu Swarup, Secretary, Department of Biotechnology through video conferencing.
- It will also look into the use of existing diagnostic tests and the development of additional methodologies to understand the spread of emerging diseases.

Key Points :

- She also inaugurated the International minisymposium on 'Essentials of One Health'.
- Emphasis was laid on the need of a holistic approach to understand the health of human, animals and wildlife to minimize the damage caused by future pandemics.
- The consortium consists of AIIMS (All India) Institute of Medical Sciences), Delhi; AIIMS Jodhpur; IVRI (Indian Veterinary Research Institute), Bareilly (Uttar Pradesh); GADVASU (Guru Angad Dev Veterinary and Animal Sciences University), Ludhiana (Punjab); TANUVAS (Tamil Nadu Veterinary and Animal Sciences University), Chennai (Tamil Nadu); MAFSU (Maharashtra Animal \ & Fishery Sciences University), Nagpur (Maharashtra); and many more ICAR (Indian Council of Agricultural Research), ICMR (Indian Council of Medical Research) centres and wildlife agencies, Assam agricultural and veterinary university

In a 1st Govt Fixed Subsidy for PDM under NBS scheme

F or the first time, the Union Government has brought Potash Derived from Molasses (PDM) under the Nutrient Based Subsidy (NBS) scheme (since its inception in 2010) to reduce India's dependence on mineral-based potash. This Fertilizer is known as PDM-0:0: 14.5:0.

Objective :

To give a push to PDM manufacturing by Sugar Mills as a byproduct and reduce India's dependence on 100 percent import of more than 42 LMT of Mineral-based Potash which cost around Rs 7,160 crores annually.

Key Points :

- Through this initiative government will offer subsidy of Rs 73 per 50 kg bag of PDM sold at Rs 600-800 by fertiliser companies to farmers.
- Union Government is expected to spend Rs 156 crore annually as a subsidy on PDM and save foreign exchange of Rs 562 crores.
- This inclusion will improve the revenue of mills and the income of sugarcane growers.
- Increased variant of Fertiliser: The current inclusion of PDM into NBS made the total variants of fertiliser under NBS scheme 25.
- Till 2020, the government has fixed the subsidy under the NBS scheme for 22 varieties of fertilisers having soil nutrients namely Nitrogen (N), Phosphate (P), Potash (K) and Sulphur (S).
- In May 2021 two complex fertilisers of NPK (8-21-21) and NPK (9-24-24) were included under the NBS (made the count to 24).

Background:

Earlier in October 2021, the Cabinet Committee on Economic Affairs (CCEA), chaired by Prime Minister Narendra Modi, has approved the increase of NBS scheme rates.

 To maintain the prices of fertilizers affordable to the farmers, the Union Government has decided to increase the subsidy per bag of Di-Ammonium Phosphate (DAP) to Rs 438 and Rs 100 per bag benefit each on NPK 1026-26, NPK 20-20-0-13, and NPK 12-32-16.

ICMR releases MUDRA Toolbox in 5 Languages

Indian Council of Medical Research (ICMR) released the Multilingual Dementia Research and Assessment (MUDRA) Toolbox in five Indian languages - Hindi, Bengali, Telugu, Kannada and Malayalam.

- MUDRA Toolbox is a project led by the ICMR Neuro-Cognitive Tool Box (ICMR-NCTB) partnership to improve dementia and mild cognitive impairment research and therapeutic practices in India.
- This toolkit has several cognitive tests that can be used to examine many aspects of cognition, including executive functioning, memory, speech, and visuospatial functions.
- The initiative has started when India has over 5.29 million persons living with dementia, according to the Alzheimer's and Related Disorders Society of India (ARDSI Dementia). By 2030, the number of dementia patients is predicted to reach 7.61 million.

Amit Shah launched Development Projects in Andaman and Nicobar Islands; Mount Harriet to be named Mount Manipur

O n October 16, 2021, Union Minister Amit Shah, Ministry of Cooperation inaugurated 14 projects worth Rs 299 crore and laid foundation stones of 12 projects worth Rs 643 crore from the Netaji Subhas Chandra Bose Island in Andaman and Nicobar Islands.

With this, a development work of about Rs 1,000 crore is initiated in Andaman Islands.

The Central Government has renamed Mount Harriet, an island peak in Andaman and Nicobar Islands as Mount Manipur as a tribute to the freedom fighters of Manipur. Mount Harriet is the third-highest island peak in Andaman and Nicobar Islands.

Highlights:

India has committed to developing the most cost-effective Information Communication Technology (ICT) services for accelerating digital transformation. The telecom strategy of India is guided by the goals of affordability, accessibility, and availability of ICT services to all citizens.

Reforms in ICT :

- Increasing the spectrum tenure from 20 to 30 years.
- Simplifying the bank guarantee requirements for a licence, eliminating the Spectrum Usage Charge (SUC) for spectrum acquired in future spectrum auctions.

Interest Rates on 'Small Savings Schemes' Unchanged for Q3-FY22

The Central Government has kept the interest rates on 'Small Savings Schemes' (SSS) unchanged for the third quarter of Financial Year 2022, ie; from 1st October 2021 to 31 st December 2021 . The interest rates on SSS were altered by the Central government on a Quarterly basis \& some of the rates allocated for current quarter are:

- Public Provident Fund (PPF) 7.1%
- National Savings Certificate (NSC) 6.8 %
- Senior Citizens Savings Scheme -7.4 % (5year scheme, where interest is paid quarterly)
- Sukanya Samriddhi Yojana account 7.6%

Note :

 West Bengal is India's largest contributor in SSS, followed by Uttar Pradesh.

Takachar won the 'Earthshot Prize', also known as 'Eco Oscars', under the "Clean Our Air" category for its invention to recycle agricultural waste.

Takachar Invention - A Cheap, small-scale, portable technology that attaches to tractors and converts crop residues to bio-products like fuel \& fertilizers.

- It was released during the Azadi Ka Amrit Mahotsav week organised by MoES.

Key Points :

The DSS has extended the ability of the existing AQEWS to have decision-making capability for air quality management.

The need for the DSS was stated by the Commission for Air Quality Management (CAQM) in NCR and Adjoining Areas.

IITM, Pune also developed a website for DSS accessible at https://ews.tropmet.res.in/dss/. It will provide the following information:

- Contribution of emissions to the air quality from Delhi and the surrounding 19 districts
- Contribution of emissions from 8 different sectors in Delhi
- Contribution from biomass-burning activities in the neighbouring states
- Possible quantitative effects of interventions at the forecast air-quality event in Delhi.

PMGKP Insurance Scheme for Health Workers Extended for Another 180 Days

The Central government extended the duration of "Pradhan Mantri Garib Kalyan Package (PMGKP)", an insurance scheme for health care workers fighting COVID-19, for a further period of 180 days

 As the current term of the policy is ending on 20.10.2021, it has been further extended for 180 days from 21.10.2021.

- Until now, 1351 claims have been paid under the scheme. This scheme meant relief plans to help in the survival of the deadly situation of the country.
- The relief package includes food and components, which are divided into eight sections of the society inclusive of pensioners, women, and the disabled, poor families.
- The central government has claimed to distribute rice and wheat-based on each individual, in addition to the already existing rice distribution.

MoD Rainath Singh launched WBPMP. 1st Georissa Mawsmaiensis: New Species of **Micro Snail Discovered from Meghalaya**



team of scientists from Ashoka Trust for Research in Ecology and the Environment (ATREE), Bengaluru has discovered a new species of micro snail, named "Georissa mawsmaiensis", from Mawsmai, a limestone cave in

Meghalaya. The last such discovery was made in 1851 (around 170 years ago).

- The new species was discovered by Nipu Kumar Das and NA Aravind of the ATREE.
- The discovery is reported in the Journal of Conchology.

Note:

- In 1851, WH Benson collected & described + the new species, Georissa saritta, a member of the Georissa genus from the Musmai valley (at present Mawsmai) near Cherrapunjee (Sohra).
- Five species of cave-dwelling snails have been reported from the caves of Meghalaya.

Mawsmai cave:

- The Mawsmai cave in Mawsmai village in the East Khasi Hills district of Meghalaya is located at an altitude of 1,195 metres above sea level.
- Mawsmai in the Khasi language means "oath stone".

Key Points :

- The species of the Georissa genus are widely distributed across Africa, Asia and the Pacific
- These species are endemic microhabitats consisting of limestone caves or karst landscapes formed by the dissolution of limestone.
- Compared to the Georissa sarrita, Georissa mawsmaiensis has a different shell morphology, from shell size to the presence of 4 prominent spiral striations on body whorls of the shell.

Police Commemoration Day 2021 - October 21

T he Police Commemoration Day is annually observed across India on October 21st to remember and pay tribute to the police personnel who died in the line of duty. In 2020, Police Commemoration Day paid tribute to the personnel who lost their lives due to the COVID-19 pandemic.

The day is also known as Police Martyrs Day.

Background :

- In January 1960, the Annual Conference of Inspectors General of Police of States and Union Territories decided to observe the 21st October of every year as the Police Commemoration Day or Police Martyrs Day.
- The day was chosen to remember the sacrifice of the 10 police personnel who lost their lives on 21st October 1959 in Ladakh while fighting against the Chinese army. During the conference, it was also decided to erect a memorial at Hot Springs.

Cabinet approval on October 21, 2021

O n October 21,2021, the Union Cabinet chaired by Prime Minister (PM) Narendra Modi approved the following proposals and the information for the same was provided by Union Minister Anurag Singh Thakur, Ministry of Information and Broadcasting (MIB) during a media briefing on the Cabinet decisions in New Delhi. The Union Cabinet cleared the 'PM GatiShakti - National Master Plan (NMP) for Multi-Modal Connectivity' to economic zones. This approval comes after a week when the PM launched Rs 100 Lakh crore Gati Shakti NMP for Infrastructure Development from New Delhi.

- An Empowered Group of Secretaries (EGOS) headed by the Cabinet Secretary (Currently Rajiv Gauba) and secretaries of 18 ministries as members will be set up to review and monitor the implementation of the PM GatiShakti NMP and to ensure logistics efficiency.
- The Union Cabinet also approved a proposal to hike Dearness Allowance (DA) of the central government employees and pensioners by 3 %. It also decided to increase the House Rent Allowance (HRA) of the Central government employees from August 2021

The information for the same was provided by GAIL Chairman and Managing Director (CMD) Manoj Jain during the 5th India Energy Forum by CERAWeek in a hybrid format in New Delhi.

 This plant will supplement GAIL's natural gas business with carbon-free fuel.

Key Points :

- GAIL has finalised 2-3 sites for the hydrogen making unit including one at Vijaipur in Madhya Pradesh.
- The produced hydrogen will be sold to fertilizer units because, government has mandated to use hydrogen as fuel.
- NTPC (formerly National Thermal Power Corporation Limited) also announced a 5MW green hydrogen plant.
- Notably, to achieve the target of raising the share of natural gas to 15 % by 2030 from current 6.2 % by India, gas consumption has to rise three and half times to 600 million standard cubic meters per day.

Ridhima Veerendra Kumar breaks 7-year National record and bags gold medal in swimming

KarnatakaswimmerRidhimaVeerendrakumar bagged the gold medal in50 m backstroke for group II girls, in Bengaluru,a record-breaking performance at the 37th SubJunior and 47th Junior National Championships.

- Ridhima led with powerful strokes to clock \$29.94\$ seconds and broke the 7 -year National record of Maana Patel's record (30.37 seconds) created in \$2014.\$
- Shalini Dixit of Karnataka bagged the silver medal while Sri Nitya Sago of Telangana took bronze.
- Maharashtra's Apeksha Fernandes created a new national record in the \$50 m\$ breast stroke for group I girls.


- These laboratories will help in species identification & identify poachers, thereby helping to eliminate crime against wildlife.

- Till date, more than 250 fish species have been identified in the region.

Generally, RBI governors are given a 5-year term and Shaktikanta Das is the 5th governor (out of 25) to get 6 years long tenure.

The Indian Oil Corp (IOC) will set up India's first mega-scale Maleic Anhydride Plant with an outlay of Rs 3, 681 b crore to manufacture value-added chemical products at its Panipat refinery and petroleum complex (PRPC) in Haryana.

The project will be commissioned in 54 months.

Key Points :

- This proposed project will have a capacity of 120,000 tonnes per annum of Maleic Anhydride (MAH) that is used to make speciality products like polyester resins and surface coatings plasticisers, agrochemicals and lubricant additives.
- It will also manufacture 20,000 tonnes a year of 1,4 -Butanediol (BDO) that finds applications in Poly Urethanes (PU) and Poly Butylene Terephthalates (PBT) viz. engineering grade plastic and biodegradable fibres.
- It will also create 16,000 tonnes of Tetra Hydro Furan (THF) to accelerate the growth of the pharmaceutical industry. THF is widely used in adhesives and vinyl films.

Need behind this Plant:

Presently, the above-mentioned high demand chemicals are mostly imported by India. The proposed plant will reduce import dependence and save foreign exchange of about USD 150 million per year, catering to Aatmanirbhar Bharat.

Annually 22,000 Girls Die due to Pregnancy in Child Marriage-Report

G lobally, Child marriage kills over 60 girls a day, of which South Asia is responsible for 6 deaths a day, as per the "Global Girlhood Report 2021: Girls' Rights in Crisis" report released by Save the Children International on the 'International Day of the Girl Child' (11th October).

 The report estimates that annually 22,000 girl child die due to child marriage, with pregnancy \& childbirth being the major cause of death.

Note :

 In 1978 Government of India had amended the Child Marriage Restraint Act, 1929 & raised the legal age for Marriage is 18 years for Girls and 21 years for Boys. Overview of the Report:

- West & Central Africa is responsible for over half the deaths related to Child marriage, nearly 9,600 annual deaths or 26 deaths a day. The region also records the highest number of Child marriages in the world.
- South Asia is responsible for 2,000 child marriage-related deaths every year, which is around 6 deaths a day, which is followed by East Asia & Pacific with 650 annual deaths or 2 daily deaths.
- Nearly 80 million child marriages were prevented in the last 25 years, but the situation worsened during the Covid-19 pandemic.
- Girl children faced increased risk of violence during the lockdown, and an estimated 10 million girls will be victims of Child marriage by 2030.
- The report advises governments to prioritize issues related to girl child & genderbased violence.
- The organisation is calling on governments to Raise girls' voices; Address immediate and ongoing risks of gender-based violence, including child marriage; Guarantee the rights of all girls; Ensure the safe and unrestricted participation of female humanitarian staff in all humanitarian response efforts; Join the Generation Equality movement.

G erman rail operator Deutsche Bahn and industrial group Siemens unveiled the world's first automated, driverless train in the city of Hamburg, Germany. According to them, it is more punctual and energy efficient than traditional trains.

IMF Report: Global Debt Increased to \$226 trillion in 2020; India's Debt in 2021 Projected at 90.6%

A n Indian-American astronaut is part of NASA-SpaceX's third mission to the International Space Station (ISS). The mission is set to be start on October 30th from Kennedy Space Center in Florida, USA.

- NASA's SpaceX Crew-3 mission will carry NASA astronauts Raja Chari, Tom Marshburn, and Kayla Barron as well as ESA (European Space Agency) astronaut Matthias Maurer aboard a Crew Dragon spacecraft on a Falcon 9 rocket to the space station.
- Crew-3 is the SpaceX's 5th crewed flight to space and fourth to the International Space Station. Indian-American Chari will serve as the commander of the Crew Dragon spacecraft and the Crew-3 mission.
- Raja Chari also called as "Grinder" was born in Milwaukee, Wisconsin, in 1978. He is currently a Colonel in the US Air Force.

Around USD 4 trillion required in clean energy investment to limit global warming: IEA

I n accordance with the 'World Energy Outlook (WEO) 2021 report' by International Energy Agency (IEA), almost USD 4 trillion investment into clean energy is required by 2030 to meet the Paris Agreement pledge to limit the global temperature increase to \$1.5\$ degrees Celsius.

The report is released ahead of the United Nations (UN) Climate Change Conference, or COP26, which will take place in Glasgow from October 31 to November 12, 2021. WEO 2021 will act as a guidebook to COP26.

4 key areas for 1.5-degree stabilization:

Actions are required in four key areas over the next decade for 1.5-degree Celsius stabilisation. These are as follows:

- Massive push for clean electrification
- Renewed focus on realizing the full potential of energy efficiency
- Concerted efforts to prevent leaks from fossil fuel operations
- Boost to clean energy innovation.

Key Points :

- The analysis in WEO-2021 is premised upon 'Net Zero by 2050: A Roadmap for the Global Energy Sector', published earlier this year.
- The report has highlighted India's efforts in financing projects catering to the Paris Agreement like rapid expansion of solar PV (photovoltaic) to achieve 450 GW (Giga Watt) target for renewable energy by 2030.

In the region of Asia Pacific, Japan scored 1st rank with an overall score of 79.3 which is followed by Singapore (77.4), and New Zealand (76.8).

I ndia has ranked 79th out of 139 countries and jurisdictions in the World Justice Project's (WJP) Rule of Law Index 2021\$ report.

- The WJP Rule of Law Index 2021 ranks the countries based on scores ranging from 0 to 1, with 1 indicating the strongest adherence to the rule of law. It measures how the rule of law is experienced and perceived worldwide. Pakistan has ranked lowest at 130.

UNEP Production Gap Report 2021: World Govt's Fossil Fuel Production Plans Exceeds Paris Limits

In October 2021, the United Nations Environment Program (UNEP) has released the Production Gap Report, 2021, the report analyses the 'production gap' i.e. the difference between governments' plan for fossil fuel production and the globally agreed climate limits (including the Paris climate agreement).

 As per the report, the world's government plans to produce more than twice (around 110 percent) the amount of fossil fuels in 2030, than would be consistent with limiting warming to 1.5 degree celcius , and 45 percent more than consistent with 2 degree celcius.

 Governments' production plans and projections would lead to the production of around 240 percent more coal, 57 percent more oil, and 71 percent more gas in 2030.

Key Findings of the Report :

- As per the projection of the current report, which is the 3rd Production Gap Report of UNEP, the production gap has remained largely unchanged since UNEP's first analysis (in 2019).
- India plans to expand coal production by nearly 60 percent i.e. from 730 million tonnes in 2019 to 1,149 million tonnes in 2024.
- Coal production: The production gap is the widest for coal in 2030. The global countries are planning to produce 5.3 billion tonnes more coal in 2030 than is consistent with the 1.5 degree celsius. This production is equal to 75 percent of current levels of global coal production.

About Paris Agreement :

- To tackle climate change and its negative impacts, world leaders at the UN Climate Change Conference (COP21) in Paris made the Paris Agreement to reduce global greenhouse gas emissions to limit the global temperature increase in this century to 2 celcius while pursuing efforts to limit the increase even further to 1.5 celcius.
- The Agreement is a legally binding international treaty. It entered into force on 4 November 2016. Around 192 Parties (191 countries plus the European Union) have joined the Paris Agreement.

South Korea launched its first domestically developed space rocket- "Nuri"



The Nuri rocket, the first homegrown space rocket launched by SouthKorea at the Naro Space Center in Goheung, 473 kms south of Seoul, South Korea on Oct. 21, 2021.

- Although the mission was incomplete, as the third-stage engine stopped burning about 50 seconds earlier than expected, South Korea would press ahead by being the 10th nation to send a satellite into space on its own technology.
- South Korea is hoping to send an explorer to the moon by 2030. The plans to launch communication satellites and military satellites demonstrate the country's progress towards "Korea Space Age".

Pakistan to remain on 'Grey List' of global terror financing watchdog FATF

The global terror financing watchdog Financial Action Task Force (FATF) retained Pakistan in the 'Grey List' until it signifies the actions being taken against Jamaatud-Dawah chief Hafiz Saeed and Jaish-e-Mohammed founder Masood Azhar who are listed as global terrorists by the United Nations (UN). It was announced at the fifth Plenary of the FATF under the German Presidency of Dr. Marcus Pleyer, that took place on 19-21 October.

- This decision has been taken during the virtual meeting of the FATF Plenary which was attended by delegates from 206 members of the Global Network and observer organizations including the International Monetary Fund (IMF), the UN and the Egmont Group of Financial Intelligence Units.
- FATF also added Jordan, Mali and Turkey in its grey list.
- Mauritius and Botswana have been removed from the Grey List.

Key Points:

- Grey list is also called 'increased monitoring list'. Those countries who have failed to curb issues like money laundering and terror financing in their countries added in this category.
- Pakistan has two concurrent action plans
 with a total of 34 action plan items. It has now largely addressed 30 of the items.

Annual Ocean Plastic Pollution is Projected to Triple by 2040: UNEPs Report Titled from Pollution to Solution

T he new comprehensive assessment report titled "From Pollution to Solution: a global assessment of marine litter and plastic pollution" released by the United Nations(UN) Environment Programme (UNEP) has stated that without proper efforts to reduce ocean plastic pollution, the amount of plastic waste entering the aquatic ecosystem is estimated to triple from 9-14 million tons per year in 2016 to 23-37 million tons per year by 2040.

With another approach, plastic pollution is estimated to double from 19-23 million tons in 2016 to around 53 million tons by 2030. At present, the amount of plastics in the oceans is estimated to be around \$75-199\$ million tons.

Singapore to Launch Guidelines for Renewable Energy Certificates

S ingapore plans to launch standardized guidelines for renewable energy certificates (REC) in an effort to decarbonise its power sector and develop a regional grid.

Key Points of guidelines:

- Supports deployment of renewable energy in Singapore to develop regional grid which taps different types of low carbon energy sources in the region.
- This is the first of its kind in Southeast Asia which defines the types of renewable energy sources such as solar, wind and biomass that are eligible to generate RECs.

The certificates are market-based instruments where their prices are determined by market demand contained between 'floor price' (Minimum price) and 'forbearance price' (maximum price) specified by Central Electricity Regulatory Commission (CERC).

A ccording to the State of the Climate in Asia 2020, a first of its kind multiagency report published by the World Meteorological Organization (WMO), India has suffered an average annual loss (AAL) of around 87 billion USD due to tropical cyclones, floods and droughts.

- China experienced the highest ALL of around 238 billion USD followed by India and Japan (83 billion USD).
- The highest AAL was associated with drought.



M useum scientists from Indonesia and Germany have discovered 28 new species of beetles (all of genus Trigonopterus) from the Indonesian island of Sulawesi. One of the new beetle species has been named "Trigonopterus corona", which reflects the impacts of the COVID-19 pandemic on this project.

- Most of these species were collected by Raden Pramesa Narakusumo, curator of beetles at the Museum Zoologicum Bogoriense (MZB), Indonesian Research Center for Biology, from two localities of Central Sulawesi Province: Mt. Dako and Mt. Pompangeo.

South Korea Builds World's Largest Hydrogen Fuel Cell Power Plant

The Ministry of Trade, Industry and Energy of South Korea held that the 'Shinincheon Bitdream Fuel Cell Power Plant' at the Shinincheon Bitdream headquarters of Korea Southern Power in Seo-gu, Incheon has been completed and inaugurated.

- It has a capacity of 78 MW constructed in four stages from 2017.

On October 27,2021, China successfully launched an optical remote sensing satellite namely 'Jilin-1 Gaofen 02F' from a lowcost small, solid-fuel carrier rocket Kuaizhou-1A (KZ-1A) in the Jilin-1 Earth-imaging constellation.

- The Jilin-1 constellation will consist of up to 138 satellites by the end of the decade. It will contain different types of satellites to perform different roles.

South Asia Suffers most loss of Human Capital due to Air Pollution-World Bank Report

A s per the latest "The Changing Wealth of Nations 2021: Managing Assets for the Future" released by the World Bank, South Asia suffered the most loss in the world on human capital due to air pollution. The report was prepared by the World Bank, measuring wealth creation & distribution in 146 countries covering a period of 20-years from 1995-2018.

As per the World Bank, Human Capital is defined as "Earning over a person's lifetime".

Parameters Measured - Economic Value of Renewable Natural Capital, Nonrenewable natural capital, human capital, produced capital, Net foreign assets.

 This is the 1st time that the report measured Blue natural capital (mangroves & ocean fisheries)

Findings on South Asia:

- Between 1995-2018, 50 % of wealth creation was made through Human capital.
- South Asia is the most severely affected country in the South Asian region due to air pollution, which also severely impacts human capital.
- Gender parity will increase human capital by 42 percentage points in South Asia, where men account for 80 % of wealth creation.

Other Findings:

- Human Capital, the largest source of wealth generation, accounted for 64 % of Total Global Wealth Generation in 2018.
- There was an 8 % per capita decline in Forest wealth in 2018 compared to 1995 among the Low & Middle-income countries.
- With 8 % of Global population, only 1 % of the wealth creation was made from the Lowincome countries.

2015-2021 Warmest Years on record-WMO State of the Global Climate 2021 Report

A s per the provisional 'State of the Global Climate 2021 report' released by the World Meteorological Organization (WMO), the past seven years from 2015 to 2021 (1st 9-months) set to be witnessed the Warmest years on record. This increase in temperature is caused mainly due to the increase in atmospheric Greenhouse Gas (GHG) concentrations.

- 2021 will be between the 5 and 7 warmest year on record and that 2015 to 2021 will be the seven warmest years on record.
- The report provides a detailed pictures of climate indicators such as greenhouse gas concentrations, temperatures, extreme weather, sea level, ocean warming and ocean acidication, glacier retreat and ice melt, as well as socio-economic impacts.

The 26th Conference of Parties (COP26) of the United Nations Framework Convention on Climate Change (UNFCCC) is being held in Glasgow, Scotland, United Kingdom (UK) from 31st October - 12 November 2021.

- Prime Minister (PM) Narendra Modi Visited the UK to attend the COP26 from November 1 to 2,2021.
- The COP 26 is being hosted by the United Kingdom, in partnership with Italy.

India's 5 Commitments set at COP 26

- At the summit, the PM has set 5 ambitious targets for India to combat climate change. It includes that India will aim to attain netzero emissions by 2070.
 - The PM asserted that India is the only country that is delivering on the commitments on tackling climate change under the Paris Agreement.
- In order to support vulnerable island nations that are in danger of submerging because of rising sea levels, the PM urged the rich countries to provide 1 trillion in climate finance to the developing world to achieve its climate change mitigation targets.
- The PM also urged to make 'Lifestyle for Environment' a global mission.
- India's launch at COP26: At the COP26, PM launched a programme IRIS (Infrastructure for the Resilient Island States), a key India-

led initiative to boost infrastructure in small island nations.

World's 1st Green Grids Initiative Launched by Indian and UK PM Modi and his British counterpart Boris Johnson jointly launched the world's 1st 'green Grids' Initiative, the One Sun One World One Grid (GGIOSOWOG) on the sidelines of the COP26 summit.

Countries pledge to cut methane, deforestation

- A Global methane pledge was launched to make a 30 percent reduction in global methane emissions from 2020 levels by 2030. The pledge is jointly led by the United States and the European Union. So far, over 90 countries have signed the pledge.
- The pledge to stop and reverse deforestation by 2030 (not a formal agreement) was also made in the same manner. Over 100 countries including the U.S., China and Brazil have signed on to it.

Vulnerable Nations doing most to tackle Climate Crisis: UNDP Report

I n accordance with the report titled 'The State of Climate Ambition' 2021 released by the United Nations Development Programme (UNDP), vulnerable nations are doing most to tackle the climate crisis while the biggest emitters or richer countries are showing slow response towards climate crisis. Vulnerable countries are often home to the world's poorest people who are on the frontlines of the climate crisis.

Key Points :

- Notably 93 % of the Least developed countries (LDCs) and Small Island Developing States (SIDS) had submitted enhanced national climate pledges, or plan to do so. This group of LDCs and SIDS comprising 78 countries is only responsible for 7 % of global GHG emissions.
- On the other hand, only 3 members from G20 (Group of Twenty) submitted new pledges that too by missing a key cut-off date 12 October 12,2021.
- The pledges were needed to be included in the ongoing United Nations Framework Convention on Climate Change (UNFCCC) in Glasgow, Scotland for analysis.

Also, the 18 NDCs (Nationally determined contributions) submitted by G20 members, many are reliant on long-term targets lacking near-term ambition of reducing GHG (Greenhouse Gas) emissions.

The report featured the promising initiatives from ten countries that have been supported under the Climate Promise including Chile, Iraq, North Macedonia, Papua New Guinea, Zimbabwe, Somalia, etc.

It provides global assessment of both the pledges already submitted to the UNFCCC as well as ambition intentions of countries that are still planning to submit. It also compares current trends against those that were assessed in the first NDC Global Outlook report in 2019.

UNSC Adopted First of its Kind Resolution on 'Protecting education from Conflict'

On 29th October 2021, The United Nations Security Council (UNSC) adopted the first of its kind resolution (resolution 2601) on protecting schools and civilians connected with schools including children and teachers during armed conflict.

- The resolution condems the attacks against schools, children and teachers and urges the conflict parties to safeguard the right to education.
- It also condemns attacks against schools and hospitals as well as denial of humanitarian access by parties to armed conflict and all other violations of international law.

China launches 3 Remote Sensing Satellites using Long March-2D



O n 6th November 2021, China successfully placed 3-remote sensing satellites into orbit using the Long March-2D rocket. The satellites belonging to the Yaogan- 35 family were launched from the Xichang Satellite Launch Centre in Sichuan province of China.

- This also marks the 396th mission for the Long March series carrier rockets.
- Long March rockets, developed by the China Aerospace Science and Technology

Corporation, are responsible for almost 96.4 % of all Chinese space missions.

 Previously in 2019, China made the 300th successful mission using Long March rockets, since its inception in the 1970s.

Frequency of Chinese Rocket Launch:

- 37 years for first 100 launches
- 7.5 years for second 100 launches
- 4 years for third 100 launches
- And in less than 2 years it is set to complete the next 100 launches.

 The appearance of words related to Vax such as 'Vaccinate' have increased 34 times and 'Vaccination' have increased 18 times.

- Vax or Vaccine is derived from the Latin word 'Vacca', meaning cow and defined as Vaccination.

Australia to send Rover on Moon in 2024 to search Water



P rivate companies in Australia and Canada in collaboration with University of Technology Sydney are all set to send a rover on the moon to hunt water by mid-2024. This will be the first rover with Australian-made components to make it to the Moon.

 It will be launched through the Hakuto lander made by ispace, a lunar robotic exploration company based in Japan.

Features of Rover :

- Developer- ispace
- Weight- 10Kg
- Measurement- 60x50x50cm

Focus of mission :

- To identify regions on the Moon with abundant water sources that can produce more usable water for human consumption, sample processing, mining operations and food growth.
- This would also set the foundation for the establishment of a manned Moon base for further space exploration.

Key Points:

- The rover will have an integrated robotic arm created by the private companies Stardust Technologies (based in Canada) and Australia's EXPLOR Space Technology.
- The arm will collect high-resolution visual and haptic data using cameras and sensors which will be sent back to the mission control centre at the University of Technology Sydney.
- It will also collect information on the physical and chemical composition of lunar dust, soil and rocks.

Static :

- Moon experiences day and night cycles, just like Earth, but one day on the Moon lasts 29.5 Earth days.
- The surface temperatures of the moon reach up to 127 degrees Celsius during the day and falls as low as -173 degree Celsius at night.

Global Drug Policy Index 2021: India Ranks 18 out of 30 countries; Norway Tops

I ndia ranked 18 out of 30 countries in the 1st edition of the Global Drug Policy Index which was released by the Harm Reduction Consortium in November 2021.

- The index ranks Norway, New Zealand, Portugal, the United Kingdom (UK) and Australia as the top 5 countries on humane and health-driven drug policies.
- The Global Drug Policy Index, a new tool that offers the first-ever data-driven global analysis of 30 countries' drug policies and their implementation in a systematic, comprehensive and transparent manner.


